In Memoriam: Rhoda Silzer

Over the years Rhoda served as President, Vice-President and Director on the board as well as chairing several committees, serving, with her husband Bruce, as part of the unit management team and taking on the role of Producer or Executive Producer on numerous productions.

Rhoda had a skill for seeing people's potential and encouraging them to step up and step out. A life long coach and teacher, she brought those skills with her here and showed so many folks what their true potential was.

During her tenure as President she founded many initiatives but the one she was most proud of championing was the creation of our youth program - SMTY. One of which will be dedicated to Rhoda.

Rhoda was a force of nature. Her fearlessness empowered others and helped them to be successful. She was a gracious mentor, always willing to share sound guidance and advice. Most of all, she was a supportive friend with a cheeky sense of humour and quick smile.

As the place in the unit that welcomes all those who enter, it seemed like the appropriate room to name for Rhoda who was known for greeting newcomers and making them feel comfortable and included.

We love you and miss you, Rhoda





Background of SMT

60 years and going strong!

SMT has come a long way since our humble beginnings in 1962 as a new initiative by the senior choir at *The Church of the Master*. The group decided to add Gilbert and Sullivan operettas and Broadway musical reviews to their repertoire and rebranded this new effort as *The Light Opera of Scarborough*. Our first performances were held at Cedarbrae Collegiate.

In 1969 *The Light Opera of Scarborough* changed venues to *Playhouse 66* and began performing as *Scarborough Music Theatre*. The company played to appreciative audiences there, eventually moving to the newly built Scarborough Village Theatre in 1982.

Today we continue to hold performances at The Scarborough Village Theatre, the only theatre – professional or other – serving the community of Scarborough! In fact, we are celebrating 40 years at SVT this coming season.

In February of 1997, SMT moved its base of operations to 51 Estate Drive. Know affectionately as "The Estate", this has been our home for over 20 years. It is where we hold rehearsals and workshops, build sets, store materials, hold administrative meetings, and run a number of additional theatre-related programs.

In 2008, SMT became a registered charity to recognize our mandate of bringing affordable, quality musical theatre to our community as well as providing performance, technical, and administrative learning opportunities to our members.

In 2015, SMT expanded our educational mandate to include educational theatre camps and programs to youth in our community under the SMTY banner. Over the past few years the program under the leadership of Elizabeth Van Wyck and Amanda Sinclair has bloomed to include 1 mainstage youth show, a spring cabaret, a March Break Camp, 2 Summer Day Camps and a Teen Intensive camp each year.

We also continue to produce three mainstage musicals each year from more traditional shows like Oklahoma, The Music Man, and Anne of Green Gables to more modern shows that challenge our patrons, performers and designers like The Addams Family, Little Shop of Horrors, and Next to Normal

60 years. Over 180 shows. Hundreds of volunteers working on and off stage to entertain thousands more - all for the love of a tradition of storytelling that stretches back as far as human history.

Next year we look forward to a return to our subscription season and the celebration of over 60 years of bringing performing arts to the Scarborough area.



Special Projects

Covid: What Did We Do?

(Dot Routledge)

This past year has seen us tentatively move back to rehearsals and performances. In preparation we revised our Unit Covid Protocols to reflect the direction of the Ontario and Toronto governments. Although we were much more conservative in releasing restrictions.

Our protocols included masking, physical distancing, rapid testing, room capacities and enhanced cleaning.

The unit had signage reflecting the protocols and a document with all protocols was made available to individuals working in the space.

For those involved in our mainstage show, we procured rapid tests and each participant did a test before coming to rehearsals or to shows. Crew members remained masked at the theatre and the full tech team had alternates.

At this time, all participants in our programs (on and off stage) must be fully vaccinated and show proof of vaccination.

We are hopeful that the situation will continue to improve and that we will find our new normal in the near future.

Unit Search and Renovation

(Mark Tingle and Keith Hebert)

A special thanks to Rhoda and Bruce Silzer for the past many years working with me as members of the Unit Management team. Your contributions were truly appreciated. Keith Hebert has joined the team to help manage the unit going forward.

New Unit Search

With our lease expiring in July 2022, we began the process by reviewing the requirements for the unit; Rehearsal Hall(s), Workshop, and Green Room waiting area), storage was all identified. Rhoda Silzer chaired the committee, and they documented the requirements and workable solutions required to suit our current needs. Mark Tingle took over from Rhoda in December.

The 51 Estate unit is 3,800 square feet. The unit search was officially started in December with a conversation with our landlord about how much our rent might increase. Previous rent was \$7 sq foot, plus taxes, maintenance, and insurance (TMI) of \$4 sq foot. He gave the indication that we would be seeing rent increases to about \$15/\$16 from \$11, however at that time it was too early to provide accurate information being more than 6 months prior to a renewal.

We began by scouting industrial parks in Scarborough, seeing if we could find better options. Thinking that expanding the size of the unit would allow for more revenue options (expanded programming, youth programs, workshops, rentals, etc.). One large unit or two smaller units (one for rehearsals, and one for the workshop) was the main thought. Also noting that moving the unit would be a monstrous task taking many person hours and about \$30,000 in expenses.

We leveraged a commercial real estate agent, Matt Wood from Royal Lepage Commercial, who aided us in searching for one large segment-able unit or two separate unit close by each (one for rehearsals, and one for the workshop).

In the end we found the availability of industrial units very limited , due to COVID many companies had moved to a delivery model from a retail store and snapped up units in our size range.

The committee recommended staying where we were, as our landlord did hold to a \$4 square foot increase. A new 5-year lease was signed in March. The committee also recommended renovating the current unit so that rehearsals and building in the workshop could happen simultaneously which increases revenue earning options.


Unit Renovations

- Mark, Keith, and a number of volunteers began work on the renovations which include:
- Soundproofing the wall between the rehearsal hall and the workshop
- Air purifiers and air conditioning to the rehearsal hall and green room
- Expanding the props area
- A new configuration for the workshop
 - Light replacement with eco-friendly and much brighter LED bulbs
 - Reducing the number of platforms in the workshop opened up the space and to resolve a fire sprinkler issue.
 - Adding dust collection in the workshop
- A giant purge of old set pieces and props occurred over the past year. All items were
 evaluated for square footage cost and determined if it was reasonable to keep or toss.
 We filled five large garbage bins.

In the end, we have improved our workshop immensely, more room to work and more tables and better tools. The ability to build 24/7 and during rehearsal will be a game changer on both sides of the wall. We genuinely appreciate all the help of the volunteers who joined us on clean up days.

Investment Plan

The Board has approved a new investment policy plan to go along with a loan we received from the Business Bank of Canada at an exceptionally good rate.

Lynette Hines, our former Treasurer had been using GICs to reserve funds for certain occasions, like a pandemic, and SMT survived partly due to her due diligence, thank you Lynette!

The new plan is to invest in low-risk mutual funds, and to build a pot of money that could be used to buy an industrial unit in the future (15-year plan). SMT certainly has enough in the operating account to conduct business for our upcoming season, and this will be accessible if needed in an emergency.



Events and Audience Engagement

The Fantasticks

What a lovely little show this was!

The Fantasticks is a show that many have heard of, but haven't seen. It proved to be a good choice for a Covid-era show. It met a number of criteria, especially the need for a small cast and orchestra to allow for social distancing. This gave us the opportunity to bring a little-known musical to our audience.

Putting on a production during the times of Covid was a challenge. Changing public health guidance, the need for social distancing and masking, regular testing, all made things a bit more complex. And, of course, having to reschedule the run to May was a disappointment, especially since that meant dropping You're a Good Man Charlie Brown.

However, the cast and the production team were terrific. They coped with all those challenges with aplomb and never lost sight of the final end goal: to put on a show that will wow our audience. And that they did!!

We had a terrific production team, many of whom were working on an SMT show for the first time. Because of Covid, some original team members had to drop out, which meant some production staff joined the team with very little time before opening night. However, the entire production team needs congratulations for pulling it off, and presenting a great show.

Kudos to the entire cast, many of whom were stepping on the SMT stage for the first time. All of them agreed to stay with us after the run was postponed to May. Each night, the audience was charmed by the delightfully whimsical story they told. The numerous plaudits from audience members confirmed it.


This year due to ongoing covid restrictions the sing-along portion of the cabaret was not an option, and we expanded to 2 evenings to accommodate physically distanced seating.

Department / Committee Reports

Props Department

(Sue Smith and Andy Smith, Props Managers)

The resumption of production resulted in two inquires about props, but no rentals occurred. All other props have been returned.

The purging of props in the 'Annex' was completed but the Board's decision to remain at 'The Estate' and soundproofing the wall in the rehearsal hall has led to major renovations in the Props Loft.

The 'Loft' now has four storage levels; the original 'Upper Level', the 'Lower Level', a reconfigured 'Annex' and a new 'Mezzanine' level.

New sprinklers will be installed in the 'Annex' and in the 'Lower Level'. Work is ongoing in reorganizing these spaces using the new storage cart and existing shelving.

Please phone the Prop Managers regarding the availability of and accessibility to any Prop during these renovations.

The existing Props Catalogue, located on the bookshelves in the new dedicated "Rhoda Silzer Green Room" will be updated upon completion of the reorganization.

Policy Review Committee

Thanks to Dot Routledge, Robyn Hughes, Jan Harvey, Olivia Jon, Jerry Chadwick and Elizabeth Van Wyck for their work in updating our Audition Policy, COVID Policy and Workplace Safety Policy.

Similar to last year, our focus was on incorporating inclusive language and to emphasize diversity and equity in our policies. We clarified the criteria for allowing members to work in the unit, unsupervised and on maintaining "duty of care" while minors are members of the company.

Moreover, we revised our COVID guidelines according to provincial mandates. With the lifting of mask restrictions, the committee decided to strongly recommend wearing masks while in the rehearsal unit, but it would not be compulsory. As with our previous COVID guidelines, all those who are presenting symptoms or who do not feel well are asked to isolate and remain at home.

Looking forward, we will continue to revise and update these documents as provincial health mandates change and we continue to monitor the efficacy and wording of our policies.

Hiring Committee

The Hiring Committee for the 2022/2023 season included: Olivia Jon and Mark Tingle (Co-Chairs), Jan Harvey, Judy Gibson, and Ori Siegel.

We conducted interviews over two days (Thursday June 9, 2022 and Sunday June 12, 2022) for Directors, Music Directors, Stage Managers, Choreographers and Producers for the upcoming season.

We were seeking to fill all positions for "Bridges of Madison County" and "Godspell" and only Producer(s) for "You're a Good Man, Charlie Brown" (as Sergio Calderon had previously been slated to direct the show along with his team: Sabrina Hooper, Miguel Malaco and Amanda Cook).

Dealing with the pandemic, we were uncertain as to who would apply and we wanted to ensure that we had individuals and teams who had strong vision, background/experience and a support system to successfully mount our first full subscription season since 2019. Moreover, we wanted to be fiscally responsible and considered proposals based on their artistic merit and addressed concerns if they posed budgetary constraints. In the end, we were fortunate to have some outstanding individuals and teams apply for the upcoming season. The committee collaborated well together and it was a pleasure to serve with all of those involved.

For future reference, a suggestion was offered that we should have a checklist for those who are new to the interview process. Perhaps a breakdown of "best practices" for presenting your proposal, who are the people on the panel and expectations about interviewing as a team.

Publicity and Marketing

After a quiet couple of years this season brought Dara's Dream and The Fantasticks back to the stage with limited audiences. In addition to the many people who saw the shows we had many people who said they weren't quite ready to come back yet and we look forward to seeing them return to the theatre over the coming year.

The largest publicity event was preparing for our first subscription season since before Covid. The Theatre Scarborough season brochure went out and a large number of our subscribers renewed their subscriptions. Another significant portion of the pre-Covid subscribers chose to take advantage of our offer to pause their subscriptions for another year with plans to return for 2023/24. Any subscribers who return mid-season will be able to purchase their tickets to single shows at the subscriber price and many of them have already purchased tickets for Godspell later in the season.

In the archives, we have continued to digitize material as we find it. The greatest archive accomplishment of the pandemic was finding the last of the missing programmes for our mainstage shows for the past 60 years. When digital copies of the early SMTY shows are added to the archive shortly we will only be missing three programmes, all from children's shows in the 80's. (The Girl In The Tower from December 1986, Pinocchio from 1985, and A Friend Is A Friend from December 1983 just in case anyone happens to find them stashed away somewhere in a drawer...)

Membership

It was a slow year for memberships since we did not have a show on the main stage until May when we presented The Fantasticks.

We are pleased to announce one new Life Member this year Olivia Jon. Congratulations Olivia!

In order to encourage renewal of our memberships for the upcoming season, in July, we introduced a sale for the 2022-23 Season, where individuals could pay \$25 for a single membership and families could pay \$50 that was valid until the AGM. We were pleased to see that several people took advantage of this sale!

Grants / Loans

SMT applied for an Ontario Trillium Grant last summer and won a \$50,000 operating grant. The funding was used towards rent and utilities (6 months), the addition of air purification and air conditioning units and we were able to replace aging equipment including the table saw and chop saw and purchase a new CNC Machine (computerized router table). This has been a money maker, our Saying and Signs fundraiser around Valentine's Day was successful, and we are still receiving the occasional order for cottage signs and other sayings. We will warm up the machine in the fall again to offer Christmas Gifts options.

We have continued to apply for grants from Trillium however we are in an extremely competitive district. Items for consideration have been expanding our Youth Programming and investigating a play group at the Papermill Theatre at Todmorden Mills.

New Finance Systems

Last year, we began the process of reviewing and testing new cloud-based accounting systems. We settled on a group of products from Zoho Corporation. Books, an accounting package, Expense, an automated expense application and Analytics, a reporting package.

Rob Lachance took on the role of Bookkeeper and has been helping with the bank reconciliations and revenue entries. I would like to thank Rob for all his work and support as a sounding board.

The financial processes and controls have been made significantly easier using this system. For example, all expenses are sent through the Expense app either for the unit or production and they each get a review and approval by a Producer, Treasurer and/or Board Signatory. All the taxes are captured along with a digital receipt (no more paper) again eco-friendly and efficient. Thank you to Duane White who functioned as the Board Signatory and did the second approvals on all expenses this season.

The reporting system makes it easy for producers to see how their show spends are progressing. I am interested to see next year's production teams use the system and hear their thoughts.
