The Story

Seeing a production of *A Christmas Carol* whether one of many films, plays, or staged readings, is a Christmas tradition. It lives on as it is a story of redemption, transformation, and hope. It reminds us to consider the impact of our decisions and actions and that by changing our actions, our behaviours, we can make a positive difference.

For Ebenezer Scrooge to embark on a journey of change, he needs the intervention of a deceased friend and three spirits to show him the impact of his small-minded, miserly ways on his life, the lives around him and the future. It is important to ensure in this production, that we feel and believe the change in Ebenezer as the story proceeds. There is a character arc that must be carefully built and revealed.

In our age of lies and income inequality, Dickens continues to remind us of the truth, to beware of Want, but particularly Ignorance. This why we must always see *A Christmas Carol* once a year – to remember, reflect and act.

Unique to this adaptation is the inclusion of Charles Dickens as a character. Dickens was famous for his readings and the premise of the play is this is a reading that comes to life.

CAST (the ages noted do not need to reflect the age of the actor- spirit is what counts!) minimally the production requires 12 actors identifying as male, 8 actors identifying as female, 3 boys and 2 girls. There will be doubling + of roles.

Male Identifying Roles

- 1. Dickens/ Businessman -he is the narrator and fills in for characters as needed. His North America tour was in 1867 when he would have been 55 years old. (side)
- 2. Scrooge -55-60 years old. He is not an old man; he just seems that way. We see him smile and transform. (sides)
- 3. Bob Cratchit/ Bill 40's Bob a good man, hard-working, not too sweet (side)
- 4. Theatre manager/ Fred/ Fan's husband Fred 30's -kind and charming, enjoys teasing his uncle, his mother's son (side)
- 5. London Bobby / Schoolmaster / Undertaker's Man
- 6. Shopkeeper / Fezziwig / Businessman
- 7. Blind Beggar/ Dick Wilkins- Fezziwig Beau/ Warden / Old Joe
- 8. Gentleman I / Fezziwig Beau/Ghost of Christmas Present (side of Christmas Present)
- 9. Gentleman 2 /Belle's husband / Businessman
- 10. Jacob Marley/Topper/ Warden/ Businessman Marley 40-50's (side)
- 11. Ebenezer (20s) / Young Husband/ Businessman Young Ebenezer (side)

12. Fezziwig Beau/Peter Cratchit (17 yrs. Old)

Female Identifying Roles

- I Flower Girl/ Ghost of Christmas Past
- 2 Mother/ Raucous Lady/ Laundress
- Woman in Black/ Mrs. Fezziwig / Ghost of Christmas Yet to Come
- 4 Fezziwig daughter/Martha Cratchit Martha Is about 15-16
- 5 Cook/Mrs. Cratchit Bob's wife (side)
- 6 Fezziwig Daughter/Sara Fred's wife / Young Wife in early 20's
- 7 Fezziwig daughter/Charwoman
- 8 Belle/Londoners/Guests Belle 20's engaged to Ebenezer (side)

Boys

- I Street Boy (Act 1) / Street Boy (Act II) age about 12 or so
- 2 Young Ebenezer/Ignorance, a ragged boy -Young Ebenezer is about 10 years old
- Tiny Tim need to physicalize an ailment using a small crutch/cane, kind, thoughtful, small 10-11yrs old

Girls

- 1. Girl (Act 1) Fan/ Want, a ragged girl Fan is about 11 years old
- 2. Belle's Daughter/Belinda Cratchit -Belinda is about 12-13

For some characters, Scrooge, Dickens, Cratchit etc. (noted on list), there will be sides from the play. All will be asked to sing a brief verse of a song of your choosing. Children and Characters without sides, will be asked to briefly tell what they like/love about *A Christmas Carol* or a favourite Christmas Story.

Ideally, we will need to hear English accents. Please contact audition4sp@gmail.com for more information about the play. Due to COVID, once you have booked your audition, we will be sending you forms to complete at home which can then be emailed along with your headshot/photo and resume. We will be managing contact, distancing, and numbers in the space.

Auditions and Rehearsals will be held at 780 Birchmount, Unit 5 (West side of Birchmount, south of Eglinton, beside the Alison's Fine Foods. TTC accessible by #17 Bus from Warden Station or any Eglinton West bus from Kennedy Station.

First read-through will be Sunday, September 24 at 1 p.m.

Most rehearsals will be held on Tuesday and Thursday evenings, 7:30-10:30 p.m. and Sundays, 1-5 p.m.

Some rehearsals and all performances are at Scarborough Village Theatre, 3600 Kingston Road (at Markham Road).

Additional rehearsals may be added as we move closer to the production opening. There may also be the need to incorporate other rehearsal days to schedule other parts of the play, i.e. Dancing rehearsals
