4.	<p>Highlights of Community Partnership Report (Katherine Turner)</p> <ul style="list-style-type: none"> Theatre Scarborough once again collaborated with Denese Matthews and StArtYPA in mid-August David Rudat attended a Mayor’s Lunch on our behalf, and also coordinated SMT entertainment at <i>Guild Alive</i> and <i>Taste of Lawrence</i> <i>Guild Days Parade</i> was attended by several members representing various upcoming shows. The councillor for the area of the theatre is now Paul Ainslie For 2019-2020, a Local Retirement home is promoting our shows and selling a 3-show package We have set aside 20 tickets for 3 shows. There was a 21-page document to fill in; the Board worked on the application and the policies required, which took a couple of months. 5.	<p>PH66/TS Season-41 Financial Report (Lynette)</p> <ul style="list-style-type: none"> An overview of the finances and appendices was provided. Members learned that good financials give you knowledge. Knowledge gives control. Control is erotic. Members were encouraged to understand the financials and become comfortable with them. Theatre Scarborough has closed the year with a net profit of \$15,101. <p>Lynette highlighted a few sections on the <u>Comparative Income/Expense Statement</u>.</p> <ul style="list-style-type: none"> Ticket Sales: Theatre Scarborough charges the groups \$1 per ticket plus 4% of the ticket price. This year's TS Revenue totalled \$18,339 Q: Why is there such a difference in Internet Fees? A: Internet went up to \$150/month this year. Q: Are we considering looking at alternate internet carriers? A: the new Board will look into this. It was suggested there are cheaper packages even if we stay with Rogers. Revenue Other is up this year – refreshments (\$11,929-\$6,934); donations (\$7,306-\$185), HST rebate on hearing assist system (\$4759) <p>Lynette highlighted a few sections on the <u>Income/Expense Statement</u>.</p> <ul style="list-style-type: none"> Several expenses are 'flow-through'; paid by Theatre Scarborough and charged back to the three groups (insurance, lease, brochure, HST rebate) <p>Lynette highlighted a few sections on the <u>Balance Sheet</u>.</p> <ul style="list-style-type: none"> Looked at chart showing outstanding gift certificates. 3 year budget – action item – consider including inflation We have reserves of \$36,500 MOVED by Lynette Hines, Seconded by Jason Silzer that we approve the Financial Statement for the year ending July 31, 2018 as reviewed by Hogg, Shain & Scheck Professional Corporation. CARRIED.
